The tenders must reach the undersigned within 21 days from the date of publication of the tender through registered post/speed post/ couriers during working hours. The envelope containing the tender must be superscribed on the top as "Supply of Equipment for MRIP project titled "Development of pH universal earth-abundant bifunctional electro catalyst for water splitting reactions", Department of Chemistry and addressed to Principal, Shailabala Women's (Auto.) GENERAL TERMS AND CONDITIONS

- The technical bid and financial bid should be sealed by the bidder in separate covers duly super-scribed and both these sealed covers are to be put in a bigger cover which should also be sealed and duly super-scribed.
- 2. The authority reserves the right to increase/decrease the quantity as per the requirement and immediate availability of funds.
- 3. The authority also reserves the right to extend the date and accept or reject the tender without assigning any reason thereof. The college will not be responsible for non-receipt of tender within the last date due to any reason including postal delay.
- 4. The Bidders should furnish proof of identical supply of any of these items to other Institutions, Universities, Colleges, and State/Public Sectors. The proof of such credentials should be furnished by the Supplier.
- 5. The technical bid will be opened first and the financial bid of the successful bidder after technical verification will be opened on the same day. The bids will be opened on date 20.08.2024 at 11 AM. The bidders are requested to present at the time of opening of the tender.
- 6. Every page of the tender document, and the documents attached there should be signed by the bidder.
- 7. The bidder/dealer/distributor should have not been debarred by any Government or other organizations. A certificate to this effect must be given as per the proforma enclosed in the tender document.
- 8. The rates should be inclusive of all costs/taxes (with breakup of GST / Taxes).
- 9. The items shall have to be delivered and installed freely in their respective place within 15 days of the issue of the order.
- 10. The Supplier shall not assign or sublet the contract to any third party.
- 11. Any dispute shall be subject to the jurisdiction of Hon'ble High Court of Odisha.
- 12. Any act or effort on the part of the Supplier to influence anybody in the institute is liable for rejection of the Tender.
- 13. The bidders should attach the following documents

- 15. Any mismatch of specification of the item in the technical bid with the required specification given in the tender will lead to rejection.

The bidders who are interested in participating in the bidding process are required to submit EMD@3% of the total bid price for different items taken together in the form of a Demand Draft /Bank Guarantee from any scheduled Bank in favor of Principal, Shailabala Women's (Auto.) College, Mission Road, Cuttack. The Micro and Small Enterprises (MSES) and start-ups are exempted from payment of EMD. The EMD of unsuccessful bidders will be returned by the 30th day of the award of the contract without any interest and the EMD of the successful bidder will be refunded after receipt of the performance security. EMD for each department must be submitted separately in the bid documents.
- 17. The successful bidders are required to submit performance security @7% in the form of a Demand Draft / Bank Guarantee from any scheduled Bank in favor of Principal, Shailabala Women's (Auto.) College, Mission Road, Cuttack. The Local MSE registered bidders if selected, will submit performance security @25% of the value of performance security (i.e. 25% of the prescribed security deposit amount). The performance security remains valid for a period of 60 days beyond the date of completion of all contractual obligations of the supplier including warranty obligation.
- 18. Any claim of exemption of EMD, performance guarantee should be supported by Government orders from appropriate authority with documentary proof.
