30 marks are allocated for the mid-semester examination and 70 marks for the end-semester examination. Out of the 70 marks, 40 are for practical work, 20 for the viva voce, and 10 for lab record.
6. It was discussed and finalized that students will be sensitized and guided to register for courses in the Swayam/NPTEL Platform for other Open Elective/Skill-based courses.


**The minutes of the meeting were as follows:**
