# .Examination Committee (EC)

The examination committee is constituted comprising Principal, as the ex-officio

Chairman, the Controller of Examinations, two members of the Academic Council, three senior faculty members of the college to be nominated by the Principal. The Examination Committee recommends the Principal the name of question setters, moderators and Examiners prepared by respective Board of Studies and vetted by CoE, to consider the reports of Board of conducting examiners (BCE), to examine and recommend the examination fee structure to the EC after getting the concurrence of Finance Committee (FC), to consider the proposals of the CoE for purchase of any equipment or infrastructural development of Autonomous Examination System.

## 2. Executive Committee (EC)

The college constitute its Executive committee to approve the fee and other charges payable by students as prescribed and recommended by the Examination Committee, to approve the rates of remuneration, honourarium, TA, DA, CA and miscellaneous expenses related to the conduct of examination, question setters, moderation, coding and valuation to UG, PG, M.Phil and B.ED examinations.

## 3. Board of Conducting Examiners (BCE)

The Board of Conducting Examiners for each department and self-financing courses is constituted under the Chairmanship of the Head of the Department/ Co-ordinator

the Dept. and two members to be nominated by the Principal outside the college. It's function is to pass the result on the basis of the reports of the Examiners and statistics of the result place before the Board by the Controller of Examinations, to review the complaint on the question and suggest measures to relief to the Controller of Examinations, who shall place the suggestion before Examination committee.

### **4.RESULT PUBLICATION**

The semester wise results of UG, PG and M.Phil classes and Annual results of B.ED self-financing courses is prepared by the Controller of Examinations as per regulations, pass the same in respective Board of conducting Examiners and examination committee and submitted to the University for approval of the Vice-Chancellor and publication of the results.

## 5.RE-CHECKING/RE-ADDITION

After the publication of Result by the Controller of Examinations, it is notified in college notice Boards and college website for wide circulation.

After the result is notified, a candidate desiring for readdition of marks/ photo copy of Answer Scripts may apply for the same in the prescribed application from available in



the college with application fee as applicable for re-addition of marks per paper and for photo copies of answer scripts within 15days from the date of publication of result. After 15days, a list of applicants specifying SL. NO, ROLL NO, Subject, paper is prepared by the officer in charge of scrutinizer and handed over to the Controller of Examinations and intimated to the students after the approval of the Principal. The photocopy of answer scripts and information regarding re-addition of marks is intimated to the candidate within 45 days.

There is no re-evaluation processes of the answer scripts, however in case of serious irregularities detected or printed out, the answer book has to be placed before a high level committee consisting of one member of the Board of Conducting examiners and one subject expert for assessment provided the difference in marks claimed is more than 10% of total marks in the paper. If the new mark awarded by the high level committee is more than 5% of the total mark, the new mark is accepted. The recommendation of the high level committee will be accepted under the approved of the examination committee/vice chancellor.
