WEBINAR ON “CARE DURING COVID-19 SECOND WAVE”

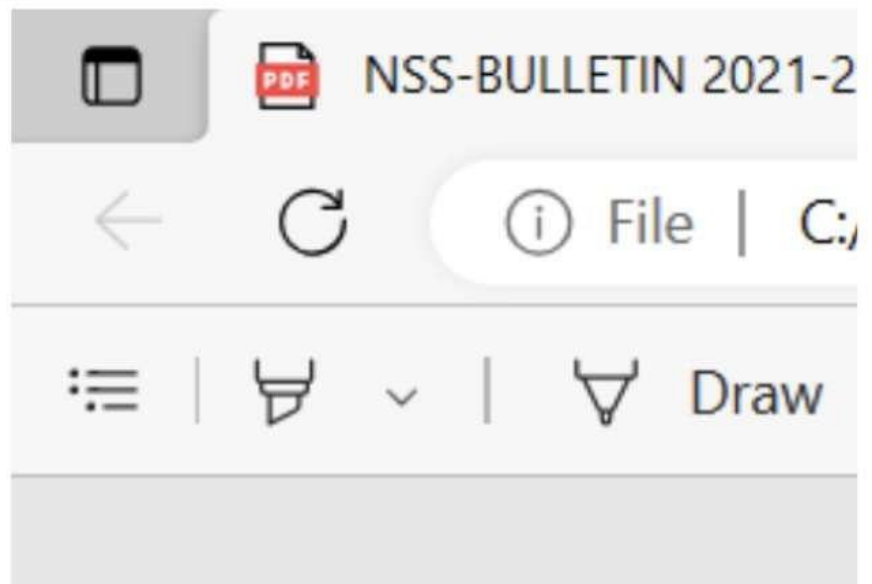


DATE: 05.05.2021
