#### SHORT TENDER CALL NOTICE

Sealed tenders are invited from Registered Firms / Manufactures / Distributors/ Authorized Dealers with valid GSTIN for the supply of Goods mentioned below to Govt. Vocational H.S. School, Cuttack. The tenders must reach the undersigned within 07 days from the date of publication of the tender through registered post/speed post/ couriers during working hours. The envelope containing the tender must be superscribed on the top as "Supply of Materials/ Equipments of SPEFL Trade" and addressed to Principal, Govt. Vocational H.S. School at Shailabala Women's H.S. School, Mission Road, Cuttack, Pin – 753001. #### GENERAL TERMS AND CONDITIONS

- 1. The technical bid and financial bid should be sealed by the bidder in separate covers duly super-scribed and both these sealed covers are to be put in a bigger cover which should also be sealed and duly super-scribed. The tender for the Govt. Vocational H. S. School must be placed with all relevant documents related to technical bid and financial bid.
- 2. The authority reserves the right to increase/decrease the quantity as per the institute's requirement and immediate availability of funds.
- 3. The authority also reserves the right to extend the date and accept or reject the-tender without assigning any reason thereof. The Govt. Vocational H. S. School will not be responsible for non-receipt of tender within the last date due to any reason including postal delay.
- 4. The Bidders should furnish proof of identical supply of any of these items to other Institutions, Universities, Colleges, and State/Public Sectors. The proof of such credentials should be furnished by the Supplier.
- 5. The technical bid will be opened first and the financial bid of the successful bidder after technical verification will be opened later. The bids will be opened on dt. 21.03.2025 at 11:00am in the New Conference Hall of this College. The bidders are requested to present at the time of opening of the tender.
- 6. Every page of the tender document, and the documents attached there should be signed by the Bidder.
- The bidder/dealer/distributor should have not been debarred by any Government or other organizations. A certificate to this effect must be given as per the proforma enclosed in the tender document.
- 8. The rates should be inclusive of all costs/taxes < with breakup of GST / Taxes).
- 9. The items shall have to be delivered freely in their respective place within 05 days of the issue of the order.
- 10. . The Supplier shall not assign or sublet the contract to any third party.
- 11. Any dispute shall be subject to the jurisdiction of Hon'ble High Court of Odisha.
- 12. Any act or effort on the part of the Supplier to influence anybody in the institute is liable for rejection of the Tender.

- 13. The bidders should attach the following documents

  - b. MSME Certificate, if any.
  - c. GSTIN Certificate.
  - d. Past Record of Supply, if any.
  - e. PAN/IT Return.
  - f. Active Dealership Certificate / Authorization from the company for participating in the tender.
- 14. The selection of L1 bidder will be based on the total quoted price item wise for all the component of given item.
- 15. Any mismatch of specification of the item in the technical bid with the required specification given in the tender will lead to rejection.
- 16. The bidders who are interested in participating in the bidding process are required to submit EMD@3% of the total bid price for different items taken together in the form of a Demand Draft/Bank Guarantee from any scheduled Bank in favour of Principal, I/C Govt. Vocational H. S. School at S.B. Women's H.S. School, Mission Road, Cuttack. The Micro and Small Enterprises (MSEs) and start-ups are exempted from payment of EMD. The EMD of unsuccessful bidders will be returned by the 30t day of the award of the contract without any interest and the EMD of the successful bidder will be refunded after receipt of the performance security.
- 17. The successful bidders are required to submit performance security @7% in the form of a Demand Draft / Bank Guarantee from any scheduled Bank in favour of **Principal**, I/C Govt. Vocational H. S. School at S.B. Women's H.S. School, Mission Road, Cuttack. The Local MSE registered bidders if selected will submit performance security @ 25% of the value of performance security (i.e., 25% of the prescribed security deposit amount). The performance security remains valid for a period of 60 days beyond the date of completion of all contractual obligations of the supplier including warranty obligation.
- 18. Any claim of exemption of EMD, performance guarantee should be supported by Government orders from appropriate authority with documentary proof.
- 19. All the items should be of reputed make and reliable.
